## PRODUCT AND MANUFACTURER

### ABOUT THE MANUFACTURER

Thermory AS is a leading manufacturer of thermally modified wood products, specializing in environmentally responsible cladding, decking, and interior solutions. Using advanced thermal modification technology, Thermory enhances the durability, stability, and aesthetic qualities of hardwood and softwood without the use of chemicals.

### PRODUCT DESCRIPTION

Thermory's Spruce timber boards undergo a thermal modification treatment that involves no chemicals in the process or in the final product. The dark color and enhanced biological durability are achieved by subjecting the timber to elevated temperatures for an extended period. After thermal modification, the timber is cut to size, molded into profiles, and any defects are removed.

The thermal modification of timber enhances its biological durability, making it suitable for both indoor and outdoor use, even in contact with weather elements such as rain and sunlight. Decking and cladding are the most common applications.

Thermally modified spruce timber cladding and decking boards. Heartwood, sapwood and knots may be present in the final product. Colour of thermally modified timber has homogenously turned darker and durability against biological agents has become higher.

## MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory.

Spruce timber is thermally modified in thermo-treatment chambers at 215 °C. Following thermal modification, the timber is planed into profiled finished products such as cladding and decking. Quality control procedures are implemented at each stage of the production process, from the receipt and storage of raw materials through to the completion of the finished products. The final product is packaged and labelled.

The use of green energy in manufacturing is demonstrated through contractual instruments (GOs, RECs, etc.), and its use is ensured throughout the validity period of this EPD.

## TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

The transportation distance is defined according to the most probable scenario - from the place of manufacturing to Denmark. According to the manufacturer, transportation doesn't cause losses as products are packaged properly. The final product is transported 1390 km (990 km by lorry and 400 km by ferry). Vehicle capacity utilization volume factor is assumed to be 1, which means full load. It may vary but as the role of transportation emission in total results is small and so the variety in load is assumed to be negligible. Empty returns are not taken into account as it is assumed that return trips are used by transportation companies to serve the needs of other clients. The fasteners used during product installation have been excluded as cut-off has been applied. In addition, most of the manufacturers products can be ordered with matched tongue-and-groove ends. Matched tongue-and-groove ends allow boards of different lengths to be installed without the need to rest them on joists. Material losses during installation were not

accounted for.

Based on Eurostat (2024) data for 2023, it is assumed that 72% of plastic packaging waste is incinerated with energy recovery and 28% is recycled. For wood packaging waste, 18% is assumed to be treated through energy recovery and 82% is recycled (Nordic Council of Ministers, 2022).

### **PRODUCT USE AND MAINTENANCE (B1-B7)**


This EPD does not cover the use phase.

Air, soil, and water impacts during the use phase have not been studied.

### **PRODUCT END OF LIFE (C1-C4, D)**

End Of Life (EOL) scenarios have been based on data from Denmark. It is estimated that there is no mass loss during the use of the product, therefore the end-of-life product is assumed to have the same weight as the declared product. All the end-of-life products are assumed to be sent to the closest facilities for recycling or incineration. Transportation distance to the closest disposal area is estimated as 50 km (C2) and the transportation method is assumed as lorry which is the most common option. At the end-of-life, in the demolition phase, 100% of the product is assumed to be collected as separate wood waste (C1) and is assumed to be sent to the closest facilities (C2) where 18% of wood is to be incinerated with energy recovery and 82% is to be recycled (C3). It is assumed that no waste is landfilled (C4) (Nordic Council of Ministers, 2022).

# LIFE-CYCLE ASSESSMENT

## CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

Bio-, glass, paper and cardboard waste is excluded by cut-off. The mass of these is less than 1% of the total mass of the product.

## VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.

## ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

This EPD represents the product group average based on production volume of thermally modified spruce boards of two manufacturing facilities. The reported GWP-fossil values have a variation range of -17% (Reola site) and +26% (Loo site) primarily due to the differences of the types of fuels used in the factories. Loo factory uses more fossil-based fuels that increase the GWP-fossil values.

## LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator for EPD Hub V3 and EPD System Verification v3.2.3. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.10.1/3.11 and One Click LCA databases as sources of environmental data. Allocation used in Ecoinvent 3.10.1/3.11 environmental data sources follow the methodology 'allocation, Cut-off, EN 15804+A2'.
